SANCTITY OF LIFE	No official position for or against abortion. However, the party leader identifies as pro-life and once spoke at New Brunswick's March For Life. While in Opposition, the PCs fought valiantly to save the modicum of legal protection for unborn children that still existed in New Brunswick, which the Liberals were repealing. This was the rule that required two doctors to sign off that the abortion is medically necessary. Since forming government however, the PCs have not re-instituted the 2-doctor rule.	• Officially supports abortion-on-demand as a so-called "right". This reveals the party has accepted the myth that the court ruled that abortion is a "right", which it never did. In fact, the Supreme Court affirmed that the state has a legitimate interest in "protecting fetal life". · The spokesperson stated the party would be willing to consider improving adoption services: "The party would like to focus on improving adoption services for women who would use that option, such as support and educating the public to remove any negative stigmas that may exist toward the adoption process."	· Officially supports abortion-on-demand as a so-called "right". · A past NDP Leader declared that all NDP MLAs must vote pro-abortion, even if it means violating their consciences and/or religious beliefs.
FUNDING ABORTIONS	Admirably, the PC government refused to divert taxpayer dollars towards funding elective abortions at a private abortuary in Fredericton, Clinic 554. This led to its eventual closure. However, the PC government has continued to fund elective abortions committed in the province's hospitals. PARENTAL RIGHTS	 Supports parental rights in education. In May 2024, after parental outcry about an external sex education group that promoted pornography and indecent sex acts to students, the PCs banned the group from giving presentations in any New Brunswick school. PC government has opposed the practice of schools hiding from parents the most intimate details of their children's lives. The party Leader and PC Education Minister supported a parental rights protest held on the lawn of the legislature. This commonsense reform was implemented under Policy 713.
